## A NEW FORM MUST BE COMPLETED FOR EACH HORSE AND SUBMITTED EACH YEAR

- Registration form must be **RECEIVED** in Extension Office by 4:30 p. m. on **April 15<sup>th</sup>**. Project changes or additions after this deadline must be approved by the 4-H Educational Board.
- You **MUST** also submit a County Jr. Fair Entry Form by the deadline in July to exhibit this horse at fair. Horses shown in Jr. Fair must be in exhibitors possession **by APRIL 15**.
- A maximum of 3 saddle and production horses may be registered by each exhibitor
- A maximum of 3 miniature horses may be registered by each exhibitor. (Mare and foal considered **one** project)
- A maximum of 4 horses may be registered for draft.
